Bylaws

- A. Bristlecone Audubon territory includes that area of northeast Nevada bounded by the counties of Elko, Eureka, Lander and White Pine. While this area is roughly the size of some eastern States (e.g. Maine), every attempt will be made to include our far flung members in all Chapter activities.
- B. Bristlecone Audubon will meet monthly either in a field setting or in a conference setting to encourage an appreciation of natural history and create and/or foster a Conservation Ethic in our communities.
- C. Bristlecone Audubon will develop a program of advocacy and science-based education focusing on the preservation, conservation and restoration of wildlife habitats.
- D. Bristlecone Audubon will actively seek conservation-oriented grant opportunities and other partnerships for on the ground habitat restoration projects and expanded conservation education in our communities.

E. All community outreach activities conducted by Bristlecone Audubon will always include a membership recruitment component.

- F. Coordination with adjacent Audubon Chapters will always be a high priority for Bristlecone, particularly when conservation issues we share in common are indentified.
- G. Coordination with National Audubon will always be a high priority for Bristlecone Audubon, especially when it comes to defining and voting on regional and national Conservation Issue priorities and Action Agendas for Audubon.
- H. Bristlecone Audubon will submit an Annual Report to our Chapter Services Representative that will include our Annual Plan for the subsequent calendar year, a Previous Year Summary, a Financial Report or a copy of the Chapter's IRS Annual Information Return (Form 990), any Chapter changes (Bylaws, 501c.3. status, etc) and an updated Chapter Leader Roster.

- I. Annual Chapter/National membership dues will remain \$20.00 into the foreseeable future.
- J. This Constitution reflects the will of Bristlecone Audubon and its founding members. It is meant to serve as a living document and therefore is subject to revision over time.

- K. Neither Bristlecone Audubon nor National Audubon shall enter into any commitment binding on the other without written authorization to do so.
- L. Any Change in Chapter Status Circumstances may arise under which either Bristlecone
 Audubon or National Audubon may choose to reconsider their relationship. In such situations, it
 is the responsibility of the Chapter Services Office to work with Bristlecone Audubon to attempt
 to return the Chapter to full activity or to compliance with Chapter Policy. The Chapter Services
 Office is encouraged to use whatever tools or resources are needed to restore the Chapter to full
 Chapter activity or to compliance. If Bristlecone Audubon is not able or willing to return to full
 activity or to compliance, then the Chapter Services Officer may recommend to the Senior Vice
 President for Field Operations (SVP) that Chapter de-certification is warranted and request
 revocation of Bristlecone Audubon's Charter. If that recommendation is approved, the SVP will
 provide sixty days written notice of de-certification to the Chapter President. Similarly,
 Bristlecone Audubon, by vote of its Board, may revoke its charter and cease to be a Chapter of
 National by providing sixty days written notice of such decision to its Chapter Services Office.
 In any case, each member of Bristlecone Audubon will remain a member of National for as long
 as their Audubon membership is current.
